Product Description

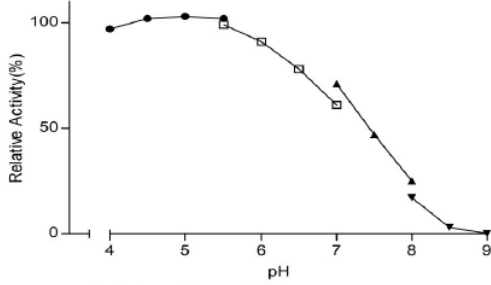

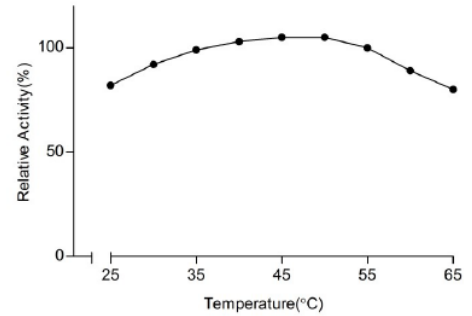
Fig.1. pH-Activity

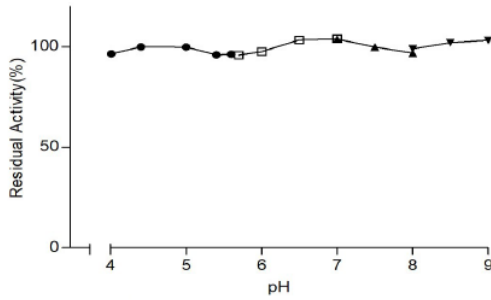

in 79mM MES buffer, pH5.7

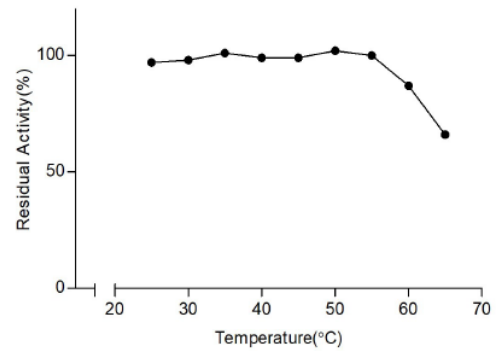
Fig.3. pH Stability
