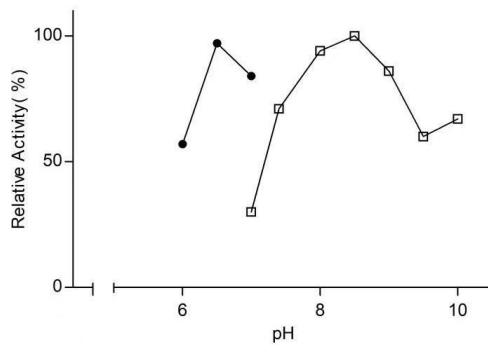

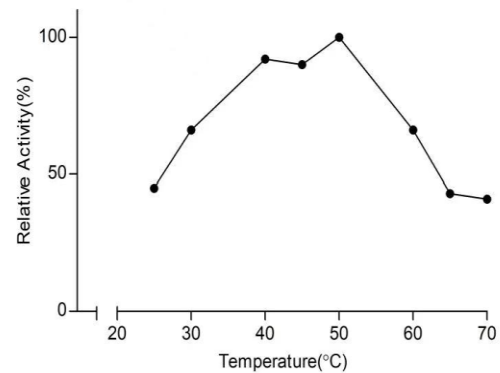
Table 1. Effect of Various Chemicals on Uricase

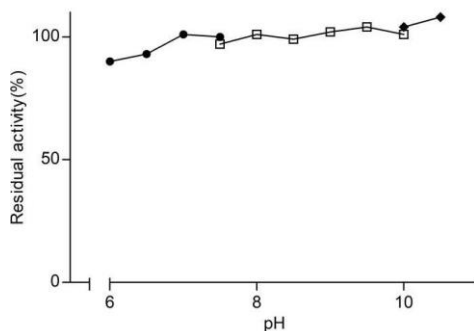

Fig.1. pH Activity


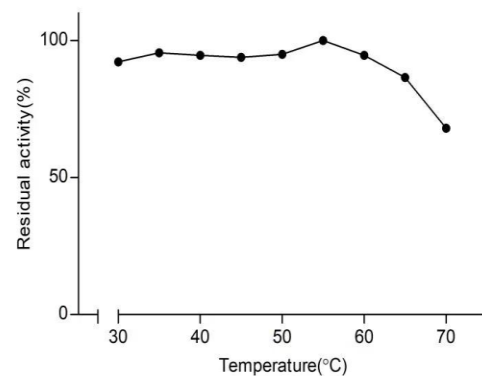
