

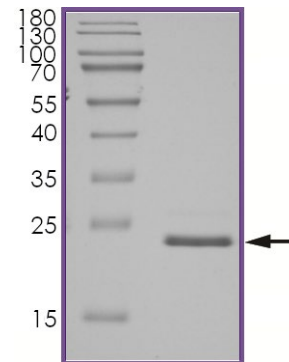

### Product Description

Recombinant *Fragaria x ananassa* allergen Fra a 1 was expressed in *E. coli* and purified by affinity chromatography using a His tag.

### Storage and Stability

Store at -20°C. To avoid repeated handling and multiple freeze/thaw cycles aliquot diluted product into smaller quantities.
