Scientific Background

PureScript III Pro Reverse Transcriptase is a next generation reverse transcriptase derived from the M-MLV (H-) Reverse Transcriptase. PureScript III Pro Reverse Transcriptase is designed for efficient reverse transcription reactions at 37°C, while retaining the thermostability of PureScript II Pro Reverse Transcriptase. For RNA with complex secondary structure, the reverse transcription reaction temperature can be raised to $50 \sim 55$ °C, avoiding the inhibitory effect of complex secondary structure on cDNA synthesis. Additionally, this product has superior continuous synthesis ability and superior impurity tolerance. It is applicable for reverse transcription of animal, plant, and microbial RNA.

Activity

The activity of PureScript III Pro Reverse Transcriptase was determined to be 200 Units/ μ I, using the unit definition below:

Unit Definition:

One unit (U) is defined as the amount of enzyme that incorporates 1 nmol of dTTP into acid-insoluble material in 10 min at 37°C with Poly (rA)-Oligo (dT) as the template/primer.

cDNA Synthesis Protocol

Notes:

Prevent RNase contamination

Keep the experiment area clean. Wear disposable gloves and masks and use RNase-free tubes and tips.

Primer selection

- 1. If cDNA products will be used for PCR
 - For eukaryotic RNA templates, use Oligo dT primer to obtain the highest yield of full-length cDNA.
 - Use of gene-specific primer (GSP) can obtain the highest specificity. However, switch to Oligo dT or random hexamers if GSP fails in 1st strand cDNA synthesis.
 - Random hexamers have the lowest specificity, and can be used for RNA templates, including mRNA, rRNA, and tRNA. Use
 random hexamers when Oligo dT or GSP fails in cDNA synthesis due to complex secondary structure, high GC content, or
 prokaryotic RNA templates.
- 2. If cDNA products will be used for **qPCR**
 - Using a mixture of Oligo dT and random hexamers can make the cDNA synthesis efficiency of each region of mRNA the same, which helps to improve the authenticity and reproducibility of the quantitative results.

cDNA Synthesis for PCR Protocol

1. RNA Template Denaturation*

Prepare the following mixtures in a RNase-free tubes.

Incubate at 65°C for 5 min and then chill on ice immediately for 2 min.

3. Run the following program for 1st strand cDNA synthesis reaction

a. This step is necessary when using random hexamers. Please skip this step when using Oligo (dT)20VN or gene specific primers.

The products can be used for PCR immediately or be stored at -20°C for up to 6 months. However, it is recommended to store at -70°C after aliquoting for long term storage. Avoid repeated freezing and thawing.

^{*}RNA denaturation benefits the cDNA yield. For cDNA >3 kb, please do not skip the denaturation step.

b. For templates with complex secondary structure or high GC content, the temperature can be increased to 55°C, which will benefit the yield.

2. Run the following program for 1st strand cDNA synthesis

85°C	5 seconds

^{*} For templates with complex secondary structure or high GC content, the temperature can be increased to 55°C to benefit the yield.
