Recombinant *Platanus acerifolia* allergen Pl a 1 was expressed in *N. benthamiana* and purified by affinity chromatography using a His tag.

Storage and Stability

Store at -20°C. To avoid repeated handling and multiple freeze/thaw cycles aliquot diluted product into smaller quantities.
