Product Description

N-Acetylneuraminic acid aldolase is a diagnostic grade reagent from a microorganism host. This enzyme is useful for enzymatic determination of N-acetylneuraminic acid and sialic acid when coupled with the related enzyme in clinical analysis.

PRINCIPLE

N-Acetylneuraminate $\xrightarrow{\text{N-Acetylneuraminic acid aldolase}}$ Pyruvate + N-Acetyl-D-mannosamine
Pyruvate + NADH + H⁺ $\xrightarrow{\text{Lactate dehydrogenase}}$ L-Lactate + NAD⁺

The disappearance of NADH is measured at 340nm by spectrophotometry.

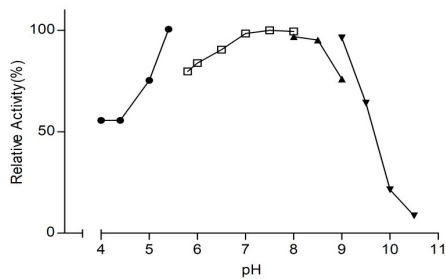

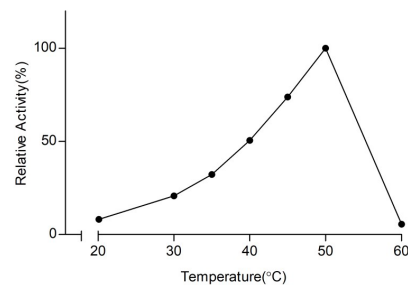

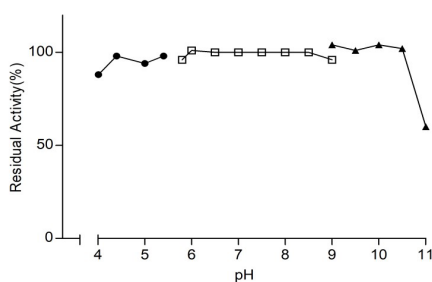
Fig.1. pH-Activity

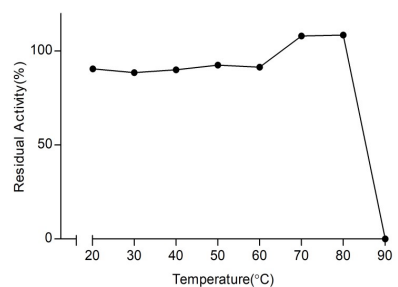
Fig.2. Temperature Activity
