Formulation

Recombinant protein stored in 50mM sodium phosphate, pH 7.5, 300mM NaCl, 150mM imidazole.

Storage and Stability

Store product at -70°C . For optimal storage, aliquot target into smaller quantities after centrifugation and store at recommended temperature. For most favorable performance, avoid repeated handling and multiple freeze/thaw cycles.

Scientific Background

Severe acute respiratory syndrome coronavirus-2 (SARS-CoV-2) remains the most rapidly spreading disease since 2020. The spike glycoprotein (S) of coronavirus, a type I transmembrane protein containing two subunits S1 and S2, facilitates viral genome entry into the host cells through the interaction with angiotensin-converting enzyme 2 (ACE2) (1). The current UK variant B.1.1.7 contains 9 out of 23 mutations in the Spike protein. Of the mutations found in the Spike protein of the UK variant, $\Delta 69-70$ and D614G have been associated with higher viral infectivity. N501Y is known to increase affinity for ACE2 and P681H mutation found adjacent to the furin cleavage site possibly plays a role in spike protein processing (2,3).

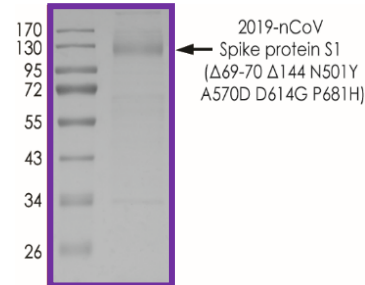

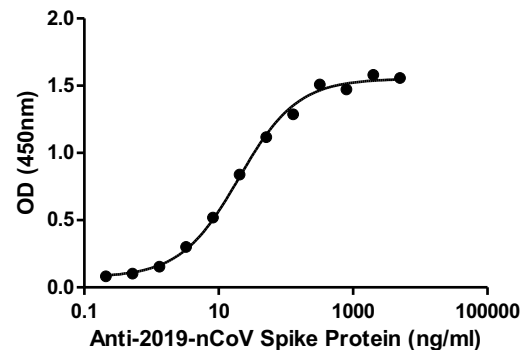
