### Product Description

Recombinant dog ACE2 Protein (18-739) was expressed in CHO cells using a C-terminal Fc tag. The gene accession number is [XM\\_014111329](#).

ACEH, Angiotensin I converting enzyme 2,

### Formulation

Recombinant protein stored in 50mM Tris-HCl, pH 7.5, 90mM glycine.

### Storage and Stability

Store product at  $-70^{\circ}\text{C}$ . For optimal storage, aliquot target into smaller quantities after centrifugation and store at recommended temperature. For most favorable performance, avoid repeated handling and multiple freeze/thaw cycles.

### Scientific Background

The angiotensin converting enzyme 2 (ACE2) belongs to the angiotensin-converting enzyme family of dipeptidyl carboxydipeptidases (1). ACE2 cleaves the angiotensin I and angiotensin II to counterbalancing ACE activity in the regulation of renin angiotensin system (RAS) (1). ACE2 also has the role in regulation of cardiovascular, renal and reproductive systems physiologically (1). In addition, ACE2 is a functional receptor for the spike glycoprotein (S) of SARS-CoV, HCoV-NL63, and SARS-CoV-2 (2), which causes the pandemic of the respiratory diseases (COVID-19) (3).

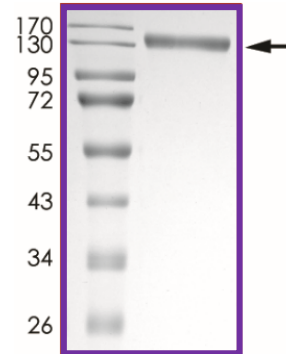

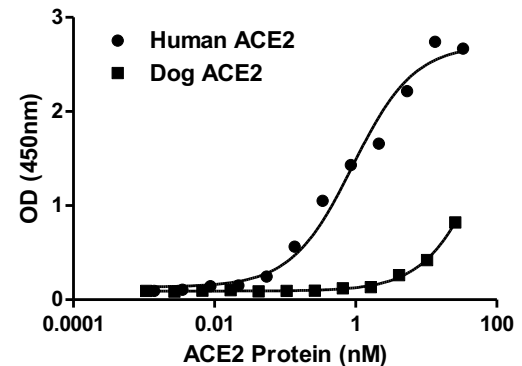
### Purity

Binding ability measured in a functional ELISA. Unlike human ACE2, Dog ACE2 (18-739) Protein (**A53C2-G341F**) does not bind well to immobilized 2019-nCoV Spike Protein RBD (**C19SD-G241H**).
